<p>We aim to conduct ourselves in a professional manner at all times and provide you with a sensitive, dignified and courteous service.</p> <p>We provide you with a detailed estimate giving an indication of the charges to be incurred and whilst we make every effort to ensure its accuracy some disbursements are not known prior to the funeral or are subject to change.</p> <p>It is the legal responsibility of the person making/authorising the funeral arrangements to settle the funeral account and any costs incurred, if the account is to be settled by someone else ie a Solicitor, Bank or other individual please provide us with the necessary contact details at the time of arranging.</p> <p>Our payment terms are 14 days from receipt of invoice, we prefer payment by bank transfer but also accept cash, Debit/Credit card, Paypal or Bankers Order. We no longer accept cheques unless agreed prior to invoicing.</p> <p>A surcharge of £150.00 is applied to all invoices, this may be deducted if the account is settled within 7 days of receipt of invoice. Outstanding monies will incur late payment charges of £1 per day until such time as the balance is paid in full and final settlement.</p> <p>We reserve the right to recover any outstanding monies remaining unpaid via collection agencies or through the Small Claims Court.
